(Non-Medical candidates will not be considered.)

2. UPPER AGE LIMIT

Not exceeding 30 (Thirty) years as on the last date of the receipt of the Applications.

Upper age limit shall be determined as on last date of receipt of Applications.

No age relaxation would be available to SC/ST/OBC candidates applying for unreserved vacancies.

Age relaxation to other categories of the candidates will also be applicable as per the DoPT instructions.

OBC candidate's eligibility will be based on the caste(s) borne in the Central List of Government of India. OBC candidate(s) should not belongs to Creamy Layer and their sub-caste should match with the entries in Central List of OBC, failing which their candidatures will not be considered under any of the applied reserved category post(s).

Only such persons would be eligible for reservation under OH quota in service/posts who suffer from not less than 40% of physical disability. Person who wants to avail the benefit of reservation would have to submit a Disability Certificate as issued by a Competent Authority in prescribed format.

The candidates are to satisfy all eligibility criteria. They must possess the educational qualification and experiences as recognized by the Govt. of India. Their candidature will be cancelled at any stage if it is found that their educational qualification or experiences is not recognized by the Govt. of India.

The posts of Tutor/ Demonstrator will be governed by CCS (Temporary Service) Rules.

3. RESERVATION OF POSTS

- a) The reservation for ST/SC/OBC/EWS/PwBD candidates is as per Central Govt. Rules.
- b) For OBC Candidate: Candidates must attach certificate valid for the posts under the Central Government of India which mentions that the Candidate does not belong to Creamy Layer. Date of issue of Certificate should not be earlier than 1 year from the last date of submission of Applications.
- c) For SC, ST, OBC & EWS Certificate should be issued by authorities prescribed by Govt. of India.
- d) Person with disability are required to produce the physically handicapped certificate (with degree of disability) in original issued by the Competent Authority (i.e. Medical board duly constituted by the Central Govt. or State Govt.) at the time of interview. Candidates with disability of lower limbs between 50 to 70% shall be considered and in case candidates are not available of such disability in the category, then the candidates with disability of lower limbs between 40-50% can also be considered for admission.

4. OTHER ELIGIBILITY CRITERIA

- a) The date for determination of eligibility with regards to age, educational qualification and experience etc. will be as on the last date of submission of application.
- b) MCI/State Registration for Medical candidates is mandatory before joining, if selected.
- c) Mere attending the interview does not guarantee the selection.

5. SELECTION PROCEDURE FOR TUTORS / DEMONSTRATORS:

- a) The screening Committee would be screening the documents submitted by the candidates before the interview and the eligible candidates as declared by the Screening Committee would be allowed to appear the for the Interview.
- b) Written examination will only be conducted when number of applicants are more than three times than the number of posts advertised. However, there will be no written test for the post against which less number of applications are received than the vacancies. The Competent Authority, AIIMS, Bhubaneswar has the discretion to decide for which post written examination to be conducted and for which post there will be no written examination. The decision thereof will be final.

- c) The merit list (selected and waiting list) for all categories i.e. UR/EWS/OBC/SC/ST shall be prepared on the basis of combined marks of written test and personal interview or only personal Interview.
- d) Any vacancy arising because of non-joining by selected candidates in this selection or by resignation of candidates, post will be offered to the candidates from waiting list according to the merit Panel. All applicants must provide latest mobile numbers and e-mail for timely communication.
